Mayor & Council - the following are my comments regarding the October 6th Council meeting:

❖ Application for a Temporary Use Permit 210 First Avenue West - it was disappointing how this matter was handled. The Town called for written public comments but there was no mention of how many comments had been received or whether members of Council even saw the submitted comments. Why ask if you don't use them? Then, the Mayor called for verbal comments, but the agenda never indicated that this would be done, and no public comments were made.

So, what can we be expecting to see now - more empty commercial space which doesn't help anyone? This seems to be a very short-sighted decision that may not benefit anyone or the Town.

- ❖ RDN Solid Waste Delegation the discussion on this matter extended into the 'Cardboard Bin' issue and then the subject of Garden Waste pick-up. On the relocation of the Cardboard Bin, an airport location was suggested. Would it be worthwhile considering setting up two different bin locations to split the volume at one location and provide more options for residents?
 - On the Garden Waste matter there are other options available from what was discussed, and I plan to send separate information to Council for consideration.
- ❖ Chartwell Speeding Problems this is definitely a matter that needs attention, and the problem also extends to other communities, so a broad concerted effort is needed or the problems will get worse.
- ❖ Memorial Roundabout excellent presentation by Mr. Weir. The ariel drone shots provided great perspective of the site and the project. This presentation should be posted as a separate presentation on the website so that more people can see it. Looking forward to seeing the finished product in November. Well, done.
